2. COMPOSITION/INFORMATION ON INGREDIENTS

Composition: Natural kelp (*Ecklonia maxima*) suspension containing various macro

and micro elements as well as cytokinins and auxins.

Sulphur (S) $0.5 \text{ g/}\ell$

Also contains: Cytokinins 1 mg/ℓ Auxins 27 mg/ℓ

3. HAZARDS IDENTIFICATION

Emergency Overview

- May cause mild eye irritation.
- Mildly harmful if swallowed.

Potential Health Effects

Inhalation:

Not harmful if inhaled.

Ingestion:

Mildly harmful if swallowed.

Skin Contact:

Causes very mild skin irritation. Not significantly absorbed through the intact skin.

Eye Contact:

Causes mild irritation to eyes.

Chronic Exposure:

4. FIRST AID MEASURES

Inhalation:

Remove to fresh air. If not breathing gives artificial respiration. If breathing is difficult, give oxygen. Qualified medical personnel should perform administration of oxygen. Keep person at rest and warm. Treat symptomatically and supportively as and when required. Obtain medical advice if necessary.

Ingestion:

Have victim rinse mouth thoroughly with water. Give water to dilute the material if victim is alert and not convulsing. Do not induce vomiting. If spontaneous vomiting occurs, have victim lean forward with head down to avoid breathing in of vomits, rinse mouth and administer more water. Never give anything by mouth to an unconscious person. Seek medical advice if necessary.

Skin Contact:

Remove any contaminated clothing. Wash skin with soap or mild detergent and water for at least 15 minutes. Get medical attention if irritation develops or persists. Wash clothing before re-use. Thoroughly clean shoes before re-use.

Eye Contact:

Immediately flush eyes with lukewarm water or saline solution for at least 15 minutes, lifting lower and upper eyelids occasionally. Check for and remove contact lenses after 5 minutes of flushing. Get medical attention if necessary.



5. FIRE FIGHTING MEASURES

Fire.

Not considered to be a fire hazard. Some could burn, but none ignite readily. Containers could explode when heated.

Fire Extinguishing Media:

Extinguish small fires with carbon dioxide, dry powder or alcohol-resistant foam. Water spray or fog can be used for larger fires or cooling of unaffected stock.

Special Information:

In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full-face piece operated in the pressure demand or other positive pressure mode. Fire may produce irritating or poisonous vapours, mists or other products of combustion.

6. ACCIDENTAL RELEASE MEASURES

Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8.

Small Spills:

Absorb with sand or other non-combustible absorbent material and put in a suitable container for reclamation or disposal.

Large Spills:

Dyke far ahead of liquid spills for later disposal. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. After spill have been cleaned up, wash area. Dispose of at an approved waste incinerator or landfill site.

7. HANDLING AND STORAGE

Handling:

Keep out of reach of animals, children and uninformed persons. Observe all warnings and precautions listed for the product.

Storage:

Keep in tightly closed container in a shaded, well-ventilated area, away from heat, sparks and other sources of ignition. Protect against physical damage.

Ventilation system:
